Annual Meeting Abstract License and Publishing Agreement

I, I (we) (“Author[s]”), in consideration of the acceptance of the work cited above (“Abstract”) for publication, do hereby grant to the American Society for Cell Biology (“ASCB”) a license to publish the Abstract in accordance with the following terms and conditions:

- (a) Retention of Rights. The Authors retain the copyright and the right to reprint the Abstract in any publication of which Authors serve as an author or editor, subject to proper citation of the Abstract as having been published on the ASCB website or in *Molecular Biology of the Cell (MBoC)* and where feasible the presence of a link to the original publication of the Abstract in one of those locations. Also, Authors are permitted to post the accepted version of the Abstract on their personal websites or in an online institutional repository provided there appears always the proper citation of the Abstract as having been published on the ASCB website or in *MBoC* and where feasible the presence of a link to the original publication of the Abstract in one of those locations. Authors further retain the right to revise, adapt, prepare derivative works, present, or distribute the Abstract provided that all such distribution is for noncommercial benefit and there appears always the proper citation of the Abstract as having been published on the ASCB website or in *MBoC* and where feasible a link to the original publication of the Abstract in one of those locations.
- (b) Licensing of Rights to ASCB. The Authors hereby grant to ASCB a perpetual, irrevocable, paid-up, world-wide license with the right to publish, distribute, reproduce, display, translate, sublicense for commercial purposes, and store the Abstract in all forms now known or hereafter devised and to authorize others to do so.
- (c) Licensing of Rights to the Public. The Authors hereby grant to the general public the nonexclusive right to copy, distribute, or display the Abstract based upon terms of the Creative Commons–Noncommercial–Share Alike 3.0 Unported license (<http://creativecommons.org/licenses/by-nc-sa/3.0>), by which the public:
 - (1) Is permitted to copy, distribute, transmit, and adapt the Abstract;
 - (2) Is **not** permitted to make commercial use of, or license or sublicense the Abstract for commercial use; and,
 - (3) Is required:
 - a. To attribute the work to the author and ASCB (in a way that does not suggest that the authors or ASCB endorse the users or any user’s use);
 - b. To include the terms of this license so that they apply to any subsequent use or distribution; and,
 - c. To respect the fair use rights, moral rights, and rights that the Authors and any others have in the Abstract.

2. Authors warrant that the Abstract is an original work of the Authors; that it does not infringe or violate any copyright, proprietary right, or any other right of any third party; that the Authors have the right to submit the Abstract; that any required attributions have been included; and that Authors agree to indemnify and hold the ASCB harmless against any claim to the contrary. Authors further warrant that no portion of the copyright to the Abstract has been previously assigned.

3. Authors have obtained written permission to use any quotation or excerpt from another work or from another’s property not in the public domain or covered by fair use provisions of the U.S. Copyright law. Proper acknowledgment has been given in the article for the use of such material.

4. Authors authorize the ASCB to modify the Abstract as necessary to prepare the article for publication—including changes in title, style, and format to conform to editorial usage, publication format, and ASCB editorial style.

5. Authors confirm that all authors listed on the Abstract have seen and agreed to all information contained in the Abstract, and that the information contained in the Abstract is available for general dissemination.

6. Authors confirm that when reporting research that involves recombinant DNA, humans, and animals, they have carried out all of the experiments in accordance with the recommendations of the Declaration of Helsinki and the appropriate National Institutes of Health guidelines and that the research protocols have been approved where necessary by the appropriate institutional committees.

7. If there is more than one author, the Author submitting this Abstract certifies that he/she is the duly authorized agent for any or all other Authors stated on the Abstract and hereby gives authorization for his/her colleagues by completing this submission.

8. If the above work was prepared by a United States Government employee(s) as part of his/her/their official duties it cannot be copyrighted and may be copied without restriction, but all other terms of this Agreement apply.
